My name is Polina Sybirtseva and I am Ukrainian who is currently studying for a master's degree in law in Taiwan. I want to share my own experience with Ukrainian students who are now faced with a difficult choice of further education after receiving a bachelor of law in Ukraine.

While I was still getting my bachelor's degree in Ukraine, I was already thinking about the future prospects of studying for a master's degree abroad. I was filled with the desire to explore new horizons and expand my academic and cultural experience.

I am sure that this experience will help me to be competitive in the labor market and will contribute to my professional growth in future.
